

he Estimator and/or Project Manager

If you read "Estimating Today," November 2006 from national, you may have read Mr. George Hague's article titled "Estimator/Project Manager-One Role or Two?" Mr. Hague touched on some items that really hit home for me personally. As I have been in the industry since 1989 as a Draftsperson (now referred to as a CADD Operator, I believe), Estimator, Project Manager and Design; I can relate to many items this article touches on.

Many companies are trying to decide if they should keep the roles separate or combine them. Personally I like the Estimator/Project Manager role at this stage in my career. I think it makes an Estimator's knowledge more well-rounded. An Estimator will see the design and installation up close and understand what was estimated and then installed. As an Estimator you see the design before there was a design through conceptual estimating. For me this has helped to understand design concepts and compare to what I had in mind. I like the process of conceptual to design to construction. In being part of the process, it has opened my eyes in many ways. I like meeting clients in the very beginning, working with them throughout the process, and then turning the project over to them.

As far as being just an Estimator for a period of time in my career, the biggest thing that turned me off as only having Estimating duties was the finger pointing when things didn't go right. I had issues when the "Field" would tell the "Office" only one side of the story and not give the "Estimating Department" an opportunity to explain or even understand. I want to understand why something didn't work. I hated hearing something months afterwards. How can the Estimator/Designer learn if they don't know what was broke and how it was fixed? Do you give your Estimators/Designers the

opportunity to go on the site and identify systems that had to be installed differently than what was designed? Do you give your Designers the opportunity to see things installed so they can understand them? If you are an Estimator do you go out on the jobs and ask questions to learn and understand? If you don't, you're missing opportunities to learn.

ASPE Code of Ethics

Basic Canons

Canon #1 Profession

Professional estimators shall perform services in areas of their discipline and competence.

Canon #2

Professional estimators shall continue to expand their professional capabilities through continuing education programs to better enable them to serve clients, employers and the industry.

Canon #3

Professional estimators shall conduct themselves in a manner, which will promote cooperation and good relations among members of our profession and those directly related to our profession.

Canon #4

Professional estimators shall safeguard and keep in confidence all knowledge of the business affairs and technical procedures of an employer or client.

Canon #5

Professional estimators shall conduct themselves with integrity as all times and not knowingly or willingly enter into agreements that violate the laws of the United States of America or of the states in which they practice. They shall establish guidelines for setting forth prices and receiving quotations that are fair and equitable to all parties.

Canon #6

Professional estimators shall utilize their education, years of experience and acquired skills in the preparation of each estimate or assignment with full commitment to make each estimate or assignment as detailed and accurate as their talents and abilities allow.

Canon #7

Professional estimators shall not engage in the practice of "bid peddling" as defined by this code. This is a breach of moral and ethical standards, and a member of this society shall not enter into this practice.

Canon #8

Professional estimators and those in training to be estimators shall not enter into any agreement that may be considered acts of collusion or conspiracy (bid rigging) with the implied or express purpose of defrauding clients. Acts of this type are in direct violation of the Code of Ethics of the American Society of Professional Estimators.

Canon #9

Professional estimators and those in training to be estimators shall not participate in acts, such as the giving or receiving of gifts, that are intended to be or may be construed as being unlawful acts of bribery.


