FEATURE ARTICLE

What is LEED? by Eddie Castaneda Jr., CPE, LEED AP BD+C

LEED stands for the Leadership in Energy and Environmental Design. The U.S. Green Building Council is a non-profit organization that is devoted to increasing the use of sustainable building practices across the United States. LEED is intended to help building owners and operators find and implement ways to be environmentally responsible and resource-efficient. Many of us have become LEED accredited professionals and those who have not have an understanding of what it takes for a building to become certified. In LEED 2009 there are 100 possible base points distributed across five major credit categories:

Sustainable Sites, Water Efficiency, Energy and Atmosphere, Materials and Resources, Indoor Environmental Quality, plus an additional six points for Innovation in Design and an additional 4 points for Regional Priority.

Buildings can qualify for four levels of certification:

Certified: 40–49 points Silver: 50–59 points Gold: 60–79 points

Platinum: 80 points and above

The remarkable aspect of LEED is that there are many different ways to achieve these levels and the creativity to which this system can be manipulated to gain a couple more points to attain a higher rating.

Instead of describing or giving examples on how some projects have exploited loopholes in LEED requirements and achieved credits for measures that they either had to do

ASPE Code of Ethics

- CANON 1 Professional estimators and those in training shall perform services in areas of their discipline and competence. CANON 2 Professional estimators and those in training shall continue to expand their professional capabilities through continuing education programs to better enable them to serve clients, employers and the industry. CANON 3 Professional estimators and those in training shall conduct themselves in a manner that will promote cooperation and good relations among members of our profession and those directly related to our profession. Professional estimators and those in training shall safeguard and keep in Canon 4 confidence all knowledge of the business affairs and technical procedures of an employer or client. Professional estimators and those in training shall conduct themselves with Canon 5 integrity as all times and not knowingly or willingly enter into agreements that violate the laws of the United States of America or of the states in which they practice. They shall establish guidelines for setting forth prices and receiving quotations that are fair and equitable to all parties. Canon 6 Professional estimators and those in training shall utilize their education, years of experience and acquired skills in the preparation of each estimate or assignment with full commitment to make each estimate or assignment as detailed and accurate as their talents and abilities allow. Professional estimators and those in training shall not engage in the practice Canon 7 of bid peddling as defined by this code. This is a breach of moral and ethical standards, and a member of this society shall not enter into this practice. Canon 8 Professional estimators and those in training to be estimators shall not enter into any agreement that may be considered acts of collusion or conspiracy (bid rigging) with the implied or express purpose of defrauding clients. Acts of this type are in direct violation of the code of ethics of the American Society of
 - Professional estimators and those in training to be estimators shall not participate in acts, such as the giving or receiving of gifts, which are intended to be or may be construed as being unlawful acts of bribery.
